



Pet Policy and Waiver

In consideration for The Daniel permitting me to keep my pet in the room assigned to me, I hereby agree to the following:

- 1. My pet is a domesticated dog or cat
2. I agree to pay a refundable deposit for my pet of \$100 per pet per stay. I understand that additional fees may apply in the event my pet causes any damage.
3. I agree to pay The Daniel any charges for any necessary cleaning or repair due to pet stains and/or damage, as determined within the sole discretion of The Daniel. I hereby authorize my credit card on record to be charged for the cost of these additional services.
4. I must keep my pet restrained on a leash or in a pet carrier when my pet is outside my guest room.
5. I must notify the front desk when I leave my pet unattended in guest room.
6. I must properly remove and dispose of any litter or waste associated with my pet on Hotel premises.
7. I understand that pets are not permitted in Hotel restaurants or other Hotel food and beverage areas, fitness center or private hot tub and sauna.
8. I understand that if my pet is in the guest room, my pet must be caged and/or I must be present in my room if and while being serviced by anyone (i.e., housekeeper, engineer, room service, etc.), unless other arrangements have been made in advance with the Front Desk.
9. I agree that I am responsible for the noise my pet creates and will ensure that my pet does not disrupt the quiet enjoyment of other hotel guests. Should my pet create any disturbances, which cause complaints to be made to The Daniel by other occupants or personnel of The Daniel, at the request of The Daniel manager, I shall immediately make arrangements to house my dog elsewhere outside The Daniel.
10. I agree that should The Daniel determine in its sole discretion that my pet is objectionable to other hotel guests, I must immediately make other arrangements to house the pet outside The Daniel.
11. I release The Daniel, its parent, subsidiaries and affiliates (the "Hotel Entities") from any and all liability for any injury and/or damage suffered by my pet.
12. I agree that I assume full responsibility for any injury or damage caused or alleged to be caused by my pet and incurred or alleged to be incurred by any guest, employee or invitee of The Daniel. I agree to indemnify, defend and hold harmless The Daniel Entities from and against any and all alleged or actual losses, claims, damages, liabilities, costs and expenses (including attorneys' fees and court costs) suffered by The Daniel Entities or asserted by any other hotel guest, invitee employee or person arising out of or in connection with my pet's stay at The Daniel.
13. I understand and agree that The Daniel retains the right to exclude my pet if, in The Daniel's sole discretion, my pet is considered dangerous by reason of size, disposition or is likely to frighten or harm other guests of The Daniel.
14. I confirm that my pet has all required and up to date vaccinations and inoculations and does not have any communicable illnesses or diseases.
15. I agree that at all times while on Hotel property I will ensure my pet complies with all relevant laws and regulations.

**If The Daniel determines any failures to comply with any part of the above agreement, you may be asked to leave The Daniel immediately and without reimbursement. **
