3. Cancellations

The following cancellation charges will apply in the event of cancellation:

1. With notice of 30 days or more before day of booked arrival of the passenger, no cancellation charges.
2. With notice between day 29 and 15 before day of booked arrival, 25% of lodging and services costs.
3. With notice between day 14 and 5 before day of booked arrival, 50% of lodging and services costs.
4. With notice less than 5 days before day of booked arrival, 100% of lodging and services costs.
