## PLEASE KEEP US INFORMED

### Please don't forget to let us know if you move, change your phone number(s), or any other vital information.

You will need to let us know if your contact information changes. We update our billing records as soon as we are informed of your new information, contact us at (909) 337-0457.

If you have any change of ownership, whether through marriage, divorce, or death of a spouse or joint tenant, you must update your deed officially with San Bernardino County. We cannot simply take someone's name off the ownership because you tell us to. Our official records must match the County Records. If you have any questions about changing your deed, your attorney should be able to help you, or you may call Denise at the resort, and she will try to refer you to a resource for help. The San Bernardino County Assessor's Office website has lots of useful information, and downloadable forms.

# What Are My Use Week Options?

Come stay at your second home, Lake Arrowhead Chalets. You can book your Use Week one year in advance by calling VRI central reservations at (949) 859-2181. Don't wait until the last minute, book as soon as possible, if you wait until the end of the calendar year there may not be any weeks left!

You can deposit your week with an exchange company like Trading Places International, RCI or II. First call VRI central reservations and book your Use Week. Then call the exchange company of your choice and tell them you want to deposit your Use Week for exchange. Once deposited with the exchange company you have two years from the arrival date of your reservation to use your banked week.

You can send a friend or family member to the Chalets in your place. Call VRI central reservations to book your Use Week. Then fax, write a letter or send an email with the name of your guest and your signature. We will change the reservation to their name. If you have any questions, call the resort (909) 337-0457.

You can place your unit up for rent. First call VRI central reservations and book your Use Week. Then we need some paperwork from you. This can be obtained on VRI's website at v<u>riresorts.com</u>, clicking on the Owner portal section to access the VRI Rental Agreement Packet. (You can also have these forms mailed to you by contacting the resort.) We will do what we can to rent out your unit on a nightly basis.

### **UNABLE TO USE YOUR WEEK?**

If you are unable to use your reserved week, or simply want to give it to a friend or family member, *please remember to notify VRI in writing of your guest's name prior to their arrival.* If your guests arrive without notification, they will not be allowed to check-in. Giving your guest a copy of the confirmation does not give us authorization to allow that person to check-in for you. We require a signed written statement from you, the owner, naming the person checking into your reservation. We appreciate your understanding in this matter.

We look forward to your guests having a memorable stay at the Chalets.
